The Critical Importance of America's Tanker Fleet

Tanker Shortage

If the United States needed to engage in aggressive foreign operations, a possibility made all the more likely by our renewed focus on great power competition, our forces would have access to only nine government and commercial tankers capable of conducting such global actions. It is estimated that American forces would require at least 80 such tankers to support any sort of large-scale military engagement. This problem has only gotten worse in recent years and there is little indication that Congress will address this glaring deficiency without your help.

While American forces were able to utilize foreign flagged tankers in the past, the strategic environment has fundamentally changed. China might have been willing to supply Chinese flagged tankers when our conflicts were in the Middle East, but they certainly won't be willing to help when our engagements are in the South China Sea. Bolstering our U.S. flagged tanker fleet would ensure America's continued dominance in global military engagements, and it would create jobs and maintain our essential shipbuilding capacity in the midst of the Coronavirus epidemic. America currently risks falling far behind our primary competitors such as China and Russia. We must ensure that our forward postured forces can be quickly and adequately resupplied via a reinforced tanker fleet, and we must use this opportunity to secure our shipbuilding industrial base.

Ask Congress to Reinforce America's Tanker Fleet

For this reason, and many more, Congress and the White House must work together to establish and fund a fleet of Tanker Security Program ships capable of meeting the needs of a forward postured American naval and Marine presence. Similar to our other U.S. flagged vessels, this program would provide a stipend to tankers in exchange for their commitment to answer the call when America's national security interests demand it. Both the House and Senate National Defense Authorization Act bills include this authorizing language. We hope the president signs it into law. **Urge him to do so!**

Destroyer Preble and Coast Guard detachment seize cocaine worth \$40 million in counternarcotics deployment. (Diana Stancy Correll)



The guided-missile destroyer Preble (**commissioned in Boston in 2002**) and its embarked U.S. Coast Guard law enforcement detachment take control of a low-profile, go-fast vessel while conducting counter-narcotics operations in the Eastern Pacific June 2. Recovered was more than \$40 million worth of cocaine.

The massive drug bust went down June 2 after a Navy P-8A maritime patrol aircraft spotted a low-profile, go-fast vessel in the Eastern Pacific. The Preble moved in for a long-range intercept and, upon arriving, employed one of its embarked helicopters to provide overwatch while the Coast Guard detachment and small boats gained control of the go-fast vessel.



"The success of this deployment was due to our Sailors and embarked Coast Guardsmen working together daily for a common cause — enhanced counter-narcotics operations," said Cmdr. Leonardo Giovannelli, Preble's commanding officer, in a Navy news release. "We thank our Preble families and friends whose unwavering support made it possible for their loved ones, our Sailors, to succeed at sea and complete our mission."
